

Foundation Highlights


The Madelia Health Foundation continues to strengthen local health care through community generosity. In fiscal year 2025, total contributions reached \$148,613.25, supporting vital equipment, education, and patient care initiatives.

Fundraising events – including the Golf Outing, 5K Run/Walk, and Tree of Remembrance – brought people together in support of our mission.

Thanks to donor contributions, the Foundation funded or supported key projects this year, including a Meeting Owl for improved collaboration, a Podiatry Procedure Chair, Ranger Fluid Warmer and Tubing, and support for the Living Meadows transportation van, which benefits Madelia Health patients. The Foundation also provided a grant for concussion software, enabling Madelia Health Physical Therapy to collaborate with Madelia Schools to enhance concussion protocols and student safety.

Investing in the next generation of healthcare professionals remains a priority. The Foundation awarded four renewable scholarships, supporting eleven students in their healthcare education with a total of \$8,500 distributed this year.

We are deeply grateful for every donor who helps make high-quality, compassionate care possible close to home.
